Treasurer's Report- Ms. Amanda Sammet, Accountant, presented the November financial reports.

MOTION was made by Ms. Linda Sentivany, seconded by Ms. Elaine Holladay, to accept the Treasurer's report. Motion carried (4-0).

Executive Director's Report-Ms. Kimberlyn MacDonald presented MACDDS updates including the announcement of Senate Bill 649 which is scheduled for the 2022 legislative session which if passed, could reduce the tax revenue received for services. Ms. MacDonald also reported that Governor Parson has been working on a budget to address workforce shortages and retention incentives for state workers. Ms. MacDonald reported that the National Guard was activated to deal with staffing shortages for the developmental disability population in Wisconsin. Ms. MacDonald reported that a Missouri Transportation Taskforce has been implemented to address the transportation crisis and as of December 1, 2021 temporary transportation services have been initiated by Empac, Ability, and Rainbow. Ms. MacDonald reported on COVID-19 virus updates. Ms. MacDonald stated that Henniges Automotive has adopted two SB40 families for Christmas, The Friends Foundation has been selected as one of Southwest Airlines, "Million Dollars of Thanks Contest" winners, and that SB40 team members are donating food items to benefit food pantries in coordination with St. Peter's United Church of Christ.

Agency Comments/Presentations- Empac, Mr. Tim Poepsel, CEO of Empac Group, stated that they have operated fiscally in the black for 2021. Mr. Poepsel reported that Empac has provided employment of 206 individuals and that paid wages have increased from previous years. Mr. Poepsel also stated that Employment Resources has increased referrals from 52 to 76. Average hours worked per week is at 24.9 for Community Employment. Mr. Poepsel introduced Ms. Sarah Gratzer as the Director of Employment Services. Ms. Gratzer announced the award of a contract for the rest area in St. Clair to maintain grounds along with other new business. Work continues with Mercy and the Washington School District to employ individuals.
